Conflict Minerals (3TG)

In July 2010, President Obama signed into law H.R. 4173, the Wall Street Reform and Consumer Protection Act. Section 1502 of that act imposes reporting requirements for US companies on manufacturers of products that contain metals derived from minerals that originate in the Democratic Republic of Congo or an adjoining country (so-called "Conflict Minerals" or "3TG" for Tin, Tantalum, Tungsten and Gold).

It is Weidmüller's policy, to ensure that our products do not contain minerals from mines that support or finance conflicts within the Democratic Republic of Congo or neighbouring countries. In this context, Weidmüller supports the "OECD Due Dilligence Guidance for Responsible Supply Chains of Minerals from Conflict-Affected and High-Risk Areas" and has organised its business processes accordingly.

In order to guarantee this, we commit ourselves to the following points:

- Weidmüller identifies all products which contains Tin, Tantalum, Tungsten or Gold.
- Weidmüller does not buy any products or materials that contain 3TG and originate directly from conflict mines.
- Weidmüller encourages its suppliers to ensure that all products and materials supplied to Weidmüller containing 3TG originate from non-conflicting mines.
- Weidmüller regularly informs its customers about the status of the above-mentioned activities.
