The disconnect terminals of the A-series are suitable for application in enclosures in atmospheres with flammable gases or combustible dust. The type of protection is increased safety, "e" - Level of Protection "ec" (EPL "Gc").

SCHEDULE OF LIMITATIONS:

The terminal blocks shall be placed inside a suitable IECEx/ATEX certified IP54 enclosure for gas atmosphere. For dust atmosphere the terminal blocks shall be mounted inside a suitable IECEx/ATEX certified 't' enclosure (IEC/EN60079-31).

The enclosure shall be constructed to block all sun and UV light from affecting the terminal blocks.

A thermal assessment for the classification into the temperature classes T6.....T1 shall be performed. No part of terminal block must exceed 130°C under any condition.

For cross connection accessories the current ratings and the resistances across the terminals have to be considered. Please refer to the table within the "Notice to Installers".

Manually cut jumper and jumpers with blank ends shall not be used.

The insulation material of the conductors shall meet the temperature requirements

In combination with other terminal block series and sizes and if other accessories are used, the applicable creepage and clearance distances shall be met.
